#### **Buckland Newton Parish Plan 2022 Consultation Results**

#### Introduction

Buckland Newton is a rural parish situated in West Dorset and lies approximately 10 miles equidistant from the county town of Dorchester and the market towns of Sherborne and Sturminster Newton. Buckland Newton Civil Parish covers an area of approximately 1,700 hectares and has a population of 661 with 314 households.

Buckland Newton produced a Parish Plan in 2013 following consultation with parishioners and the parish council agreed to update it in 2022.

A consultation exercise took place with parishioners and 314 questionnaires were sent out via the Lydden Vale magazine distribution, online via the Parish Council website, and additional hard copies were available via the parish clerk. The consultation took place in September 2022.

The questionnaire covered the following topics: employment and business, roads, traffic and transport, environment, community facilities, young person's interests, crime and safety as well as health and care. There was also a section to raise any other concerns or suggestions.

A total of 30 completed questionnaires were returned: approximately 9.5%.

Comments and feedback from the questionnaires will help inform the parish council on parishioner's concerns. The responses will form part of the discussion on drawing up the updated Parish Plan

### **Results of Questions**

For the purpose of drawing up the Parish Plan, where issues and concerns mentioned were similar in nature, they have been amalgamated under each of the main headings.

# **Any Other Concerns/Comments**

Flood Issues: In our garden, we can see where the tributaries of the R. Lydden converge. One from the Gaggle and one from the direction of Court Farm. Over the last couple of years, the Court Farm tributary has been intermittently cloudy - more often than not although currently it is clear. I have asked Martin Perrot about it and he has assured me he was fixing the 'filters'. It improved temporarily then became cloudy again. We think you must be aware of this problem.
I am pleased to say that I do not have long lists of concerns relating to village life. We are, on the whole, well provisioned, feel safe and enjoy life in this parish. However, it would be remiss to not consider those wider forces beyond the parish that reach into our lives and put stress on our community and our landscape. Our responses to economic, environmental and social challenges as individuals are important but so too is the shared experience of confronting, working through and bettering our lot. The parish is lucky to retain some good quality habitats - downland, lowland meadow, woodland, hedgerow and verge to name but a few. These places hold vestiges of wildlife once more common through the parish and still very much under threat in the wider farmed landscape. My children are growing up to know and love these wilder spaces and I hope as a community we can retain and even increase the size/quality of such places for my future grandchildren to enjoy. I fear this will not happen without giving due consideration to the management of our green spaces and how we understand, access and use them - of course this is framed by a changing climate and a biodiversity crisis rapidly unfolding and clearly visible locally.
The number of properties being built on farmland. It seems to start with one or two and then because the infrastructure is in place, more properties are built and within a relatively short space of time - there's an estate!
Despite raising out concerns (as requested) we remain happy to live in BN and enjoy the few facilities it has and the unspoilt countryside.
Until the drainage/flooding issue is sorted, there should be no further large-scale developments.
More downsizing properties
More affordable housing
Affordable housing is key to keeping village vibrant. School/shop/pub, etc.
Need for a second defibrillator in the pub area of the village.

Emergency services used the B3143 valley road to get to the village instead of the faster top road (Alternate A352).	
Our house was flooded last November by the torrent of water which cascaded down the road and through gardens. I would like action to be taken to divert water away from homes. This could be by physical barriers or improvements to the road like more effective storm drains, or by farms not ploughing in such a way as to channel water towards homes.	
The remains of the so-called 'running track' around the parish field should be removed. It was a waste of money. People find it uncomfortable to walk on, they walk on the grass. I have been told that some school children have tripped and hurt themselves when being made to trot along the track.	
Please don't think that any houses built by developers are 'affordable'. They are not affordable for those people who really need housing and this village needs some genuine affordable housing.  Poor mobile phone signal. Third world African countries have better coverage!	
It would be helpful if members of the public had an understanding of the role of Parish Councils and their powers.	
The Parish Council needs to increase its precept annually in line with inflation.	
The need to ensure that current (and future) housing stock is accessing all available grants/initiatives to improve insulation and efficient/green power use.	
The urgent need to respond and prepare for the climate emergency, locally.	
Flood management (as part of local environment strategy).	
Thank you for this opportunity to share concerns. We are looking forward to a new, dynamic and impactful Parish Plan.	
We would feel reassured if the PC were to declare a Climate Emergency as has the Government and Dorset Council. This should be behind every decision they make, eg. Construction - this should not be on ancient pasture land. Biodiversity should be protected. Houses should not be approved if they are built to rely on fossil fuels. And so much more.	
So far we are very lucky at Henley and have no real concerns.	
Thank you for helping to make and keep our village such a wonderful place to live.

Also, the Parish Council has a limited budget so decisions may have to be made as to what is reasonably practical.

The Parish Council hopes you will all become involved in helping address some of the issues raised – this is for all of the community.
